About ESG

Elizabeth Street Garden is a unique community sculpture garden located in the Little Italy neighborhood of Manhattan, between Prince and Spring streets.

Elizabeth Street Garden, Inc. (ESG) is a volunteer based 501(c)(3) nonfor-profit organization committed to exploring every option available to protect & preserve Elizabeth Street Garden and save our much needed community green space in Little Italy.

Our founding members have been involved with the community lead effort since it's start in 2013. In April 2017, united by the desire to change the way we save the garden, they formed ESG.

Elizabeth Street Garden, Inc. filed it's nonprofit Certificate of Incorporation with New York State in October 2016. On January 26 2017, Elizabeth Street Garden, Inc. received federal tax-exempt 501(c)(3) determination from the IRS.

We are a 100% volunteer-run organization. Our committed team volunteers their time and energy to organizing hundreds of free programs, tending to greenery and maintaining the space and keeping the garden open to the public year-round - over 50 hrs/week during the summer and 28hrs/ week during the winter - all the while working with local elected officials and organizations to protect and preserve Elizabeth Street Garden for our community.





Our Need for Green Space

In the crowded neighborhoods of Little Italy & SoHo, Elizabeth Street Garden is the only public green space that provides an open, tranquil environment for locals of all ages.

Washington Square Park (0.7 miles away from the Garden) & Hudson River Park (1.3 miles away) make up the majority of CB 2's open space.


Little Italy & SoHo make up 23% of CB 2's population, yet have only 3% of the district's open space. Aside from the Garden, all of these spaces are paved.

Little Italy & SoHo has an open space ratio of 0.07 acre per 1,000 residents (3 sq.ft. per resident), leaving the district with one of the lowest ratios of public open space in the city.


CB 2 has stated that the City's open space planning goal of at least 2.5 acres per 1,000 residents (109 sq.ft. per resident) is unobtainable.

Green space, once developed, can never be reclaimed. The City isn't tearing down buildings to create parks.









In April 2017, members of FESG and the original commu nity group branch off to form Elizabeth Street Garden, Inc. (ESG) which now manages the Garden, keeping the space open to the public seven days a week and providing free public and educational programming for the community.



Alternative Sites for Affordable Housing

Our community has identified alternative sites for the proposed development. Combined, these sites provide more than 10x affordable units for Seniors!

388 Hudson (pictured left): Offered by Community Board 2 as an official alternative site. This vacant lot can offer 5x the amount of units. 300,000 sq ft for housing.

21 Spring: Located next to the Garden, this building is expiring Sec. 8 (affordable housing) that could be extended. 185,000 sq ft for housing.

137 Centre: This City-owned building was allowed to be developed into luxury condos, instead of affordable housing. 41,000 sq ft for housing.

2 Howard: A Government owned parking lot. 65,772 sq ft for housing.

Site 3 of SPURA: Located at Delancey & Norflok streets. Originally planned to be half market rate and half affordable apartments, the project is now to be 100% market rate condos. 154,000 sq ft for housing.

Programming

At Elizabeth Street Garden we offer year-round free public programming for everyone! Our programs focus on gardening and education, arts and cultural events, and wellness activities. In 2017, ESG partnered with many local organizations including the Lower East Side Ecology Center, GrowNYC, Jivamukti Yoga, MoMA, CitiBabes, McNally Jackson Bookstore, NYPD 5th Precinct, and more.



Garden Education

Each season the garden provides a refuge to educate both children and adults about urban wildlife, habitat restoration, eco-gardening and sustainable stewardship. In 2017 ESG partnered with the Lower East Side Ecology Center to plant fruits and vegetables and teach over 200 local PS 1 students about composting and earthworm benefits.

United Against Development

On December 8th, 2017, the City announced their chosen developer under the continued efforts of Mayor Bill de Blasio and Councilmember Margaret Chin to destroy Elizabeth Street Garden.

In response, Elected Officials in support of the Garden united and released a statement (right) in opposition to the proposed development.

That same day, we announced that ESG will continue to pursue all options - including legal action - in order to save the garden. On December 11th, we rallied with garden supporters and elected officials on the steps of City Hall, calling on the city to rescind the RFP.

Statement from Elected Officials and Community Board 2 Opposing the City's Plan to Build Housing on Elizabeth Street Garden

(New York, NY) — Today, downtown elected officials, including State Senator Brian Kavanagh, Congresswoman Nydia Velazquez, Congressmember Jerrold Nadler, Comptroller Scott Stringer, Public Advocate Letitia James, State Senator Brad Hoylman, Assemblymember Yuh-Line Niou, and Assemblymember Deborah Glick joined with Community Board 2 Chair Terri Cude to release the following statement in opposition to the City's proposed housing development at the beloved Elizabeth Street Garden:

"The City's decision to build housing at Elizabeth Street Garden is both unfortunate and a great disappointment. We oppose this development proposal. Lower Manhattan needs both more affordable housing and more open space, and we reject as false the idea that we must choose between these two vital community needs. There's no doubt we must address our City's affordability crisis. We have all been and will remain deeply committed to that effort. But affordability cannot come at the expense of the precious open spaces in our communities. We can — and must — both build affordable housing and preserve our green spaces.

"Rather than razing a much loved and much needed community asset in Elizabeth Street Garden, the City should work with Community Board 2 to select more appropriate locations that will allow for both affordable housing and preservation of the Garden."

How We Can Save the Garden

ESG wants to save the Garden you all know and love! For this reason, we aim to protect & preserve the Garden in a way that allows the unique qualities, statuary, and architectural aspects to remain, while providing the public open green space our community desperately needs.

Below, you will find different models of how our community can save the Garden. To the right is ESG's vision for a sustainable future as a Conservation Land Trust. Please note that before any of these options can be fully pursued, we must stop the City's plans to destroy the Garden.

Mapped NYC Park Land (MPL)

HOW: Lot ownership would be transferred from DCAS to NYC Parks. A management agreement with NYC Parks could be arranged for ESG to maintain operation. The Garden would be saved in perpetuity. There is no record of a community-founded garden becoming MPL. "The likelihood of NYC Parks designating ESG as MPL is slim." *

ACCESS/HOURS: The Garden would be open dawn to dusk, or otherwise designated by Parks.

PHYSICAL SPACE: In order to abide by NYC Park regulations, all statuary and architectural elements in the garden would be removed.* Any monument on MPL would have to be accepted into the City's collection and reinstalled, costing thousands.* The planting of any tree, plant, flower, shrubbery or other vegetation requires written approval from Parks.

COMMUNITY INVOLVEMENT: The Garden would have to abide by Parks regulations. The Garden would be managed by Parks or by ESG if a management agreement can be made within Parks regulations. FINANCING: The Garden would be funded by the City, unless a management agreement with ESG were to state otherwise.



Green Thumb Garden (GT)

HOW: ESG would be transferred to Parks department, but the land would not be official MPL. Parks jurisdiction has provided significant protection for hundreds of gardens, but it doesn't have the extra protections of MPL.* Licensed garden status offers greater protection and if ever threatened, the community would be heavily involved in the process.*

ACCESS/HOURS: ESG would manage hours same as now (46hrs/wk) or more. With ESG no longer having to fight to save the Garden, we could focus our funds towards keeping the Garden open longer.

The requirement for GT is 20hrs/wk. PHYSICAL SPACE: GT garden rules are looser than MPL and could allow for most of the unique qualities, statuary and architectural aspects of the Garden to remain.* Gardening plots would remain for public gardening/farming.

COMMUNITY INVOLVEMENT: As is or more. ESG would still manage the space with

neiahbors, volunteers and staff. FINANCING: ESG would continue to raise funds. ESG would continue developing a plan to occasionally rent the Garden for private events/photoshoots in order to raise significant funds. GT gardens are eligible to receive gardening supplies and resources throughout the year.



Conservation Land Trust (CLT)

HOW: A CLT is a nonprofit corporation that develops & stewards spaces on behalf of the community

An existing nonprofit, such as ESG, can act as the CLT. As a CLT, ESG would own the land and continue to program and keep the garden open to the public.

The ways in which the land is acquired can vary. Examples include: lease agreements, land acquisition and land easements.

ESG could also partner with an existing CLT. ACCESS/HOURS: ESG would manage hours same as now (46hrs/wk) or more. A requirement could also be negotiated by the

City and Community Board. With ESG no longer having to fight to save the Garden, we could focus our funds towards keeping the Garden open longer.

PHYSICAL SPACE: As a CLT, the unique qualities, statuary and architectural aspects of the Garden would remain.

Gardening plots would remain for public aardenina/farmina.



Envisioning A Bright Future

Saved in its entirety, Elizabeth Street Garden has the vast potential to grow as an environmentally & financially sustainable energy efficient community garden with improved year-round public access. As a Conservation Land Trust, ESG will require no City funding in order to maintain the Garden's physical upkeep, hundreds of free public programs, staffing, and future plans. ESG will establish the areas listed below. These future plans are only possible if the Garden's current size and state is preserved.

SITE A ESG will use this area to build a new greenhouse conservatory for year-round gardening, harvesting & food security.

SITE B This area will be cleaned to make room for a composting station and improved volunteer/work shed and storage

SITE C The roof of the lean-to will be equipped with solar panels for energy sufficiency. The structure will be further outfitted so that it can be better utilized by the public through






